## **Background**

This **Special Meeting** of the Members is called in response to a written **Member Petition** dated **September 15, 2025**, submitted by **Stephanie Spencer** under **Article 3, Section 3.2 of the Bylaws** and Montana law **MCA § 35-2-527**, requesting that a Special Meeting be held for the limited purpose of potential removal of one or more current Directors and, if applicable, election of successor Directors.

The Board has confirmed that the petition, as presented, satisfies the requisite percentage of Member signatures to initiate the scheduling of a Special Meeting in accordance with Bylaws § 3.3 and Montana Code Annotated §§ 35-2-527 and 35-2-530, which collectively govern the notice, timing, and procedural requirements for meetings of the Members under the Association's governing documents and Montana law.

## **Limited Purpose of the Meeting**

Pursuant to **Article III, Section 3.2** of the Bylaws and **MCA § 35-2-27**, a **Special Meeting of the Members** is hereby called for the **limited purpose** of:

- 1. Reporting the certified results of a member vote conducted by written and electronic ballot regarding the proposed removal of one or more current Directors; and
- 2. If any Director positions become vacant as a result of that vote, explain the process and timeline for a follow-up member election to fill each vacancy for the remainder of the removed directors' unexpired term.
- **3.** No other business shall be conducted at this meeting. Only the matters stated above will be addressed as required per Bylaws § 3.2.

## **Voting Procedure for Director Removal**

Pursuant to **Bylaws § 4.11** and **MCA § 35-2-533**, the Board has determined this Member vote will be conducted **by written and electronic ballot** (no in-person voting).

Ballot Verification & Tabulation	December 14, 2025 (1 – 5 PM)	Conducted by the appointed Election Inspector.
Special Meeting (Results Announced)	December 14, 2025 @ 6 PM MT via Zoom	Official certification and public report of results. Documented in Association Records.

Owners in **Good Standing** (as defined below) within the Association shall have **one vote per Lot** for all voting issues of the Association. Returned ballots constitute attendance for quorum purposes (5 % = 21 Lots out of 412 Voting Lots).

## **Eligibility to Vote**

As defined in our governing documents and Montana law, including Bylaws § 4.5 and Article X, **only Owners/Members in good standing may vote.** 

A Member is in good standing when all assessments and fees are current and there are no outstanding or uncured covenant or bylaw violations. Owners not in good standing will be given written notice and an opportunity to be heard before the suspension of voting rights pursuant to **Bylaws Article X.** 

The Association's designated Election Inspector will verify good-standing status before counting any ballot. Ballots received from Members not in good standing will not be counted toward the quorum or the results.

#### **Director Removal Thresholds**

Pursuant to **Bylaws § 5.4** and **MCA § 35-2-421**, any director elected by the Owners may be removed, with or without cause, **by vote of the Owners equal to the same percentage of votes as director received in the election**.

# If Any Director Is Removed — Successor Election Process

Pursuant to **Bylaws § 5.4**, if removal creates a vacancy, the Association will conduct a **follow-up election** by written and electronic ballot to fill the remainder of the unexpired term of the vacancy.

If applicable, **successors serve only for the balance of the removed Director's term**. The next regular **Annual Meeting of Members** will occur in **April 2026**, when any regularly expiring terms are filled.

## **Election Inspector and Certification**

The Board has appointed an independent **Election Inspector** pursuant to **Bylaws § 4.11** and **MCA §35-2-533** to verify membership, tabulate ballots, and certify results. The Inspector will deliver a signed certification report to the Board within 48 hours after the meeting.
